UNITEDHEALTHCARE, STEP UP FOR STUDENTS HOLD HEALTHY-COOKING EVENT AT INCARNATION CATHOLIC SCHOOL

TAMPA, Fla. (Dec. 2, 2011) — Incarnation Catholic School's third graders today learned how to make healthy snacks from chef Jennifer Lee of *Food for Thought, Pass a Grille*, followed by the students' own cook-off competition in a special event sponsored by UnitedHealthcare and Step Up For Students, a nonprofit that administers the Florida Tax Credit Scholarship for low-income students.

Chef Lee, who specializes in healthy cooking, held two cooking demonstrations before the students teamed up to put their newly gained knowledge to the test. UnitedHealthcare executives judged the children's creations based on creativity, presentation and taste.

The event, designed to help children learn the importance of healthy eating habits, is part of UnitedHealthcare's ongoing commitment to helping Florida's youths live healthier lives, in part by supporting nonprofits such as Step Up For Students.

Step Up for Students administers an innovative program that enables corporations to redirect a portion of their Florida tax liability to fund K-12 scholarships for underprivileged students. This year, the scholarships were worth up to \$4,011 per student, which families may use toward tuition at one of nearly 1,200 schools across the state. Families also may elect to use a \$500 transportation scholarship to attend a public school in another county.

Since the program began a decade ago, companies have contributed more than \$900 million to Step Up For Students. UnitedHealthcare began supporting the nonprofit in 2009 and already has contributed a total of \$20 million to help fund nearly 5,000 K-12 scholarships.

"We are grateful that UnitedHealthcare has partnered with us in providing educational opportunities such as this for Florida's students," said Doug Tuthill, president of Step Up For Students.
